





Installation Instructions MC Gateway

Mounting

- Place the gateway on a horizontal surface (e.g., ceiling)
- Or mount the gateway on a wall:
 - Use two screws at least 6 mm (0.24") long with thread diameters of no more than 4 mm (0.16") and head diameters of no more than 8 mm (0.31") to affix the gateway to the surface. They shall be spaced 80 mm (3.15") apart.
 - Place the gateway onto the screws


Note: Do not place the gateway on a metal construction that can impair RF performance.



Configuration of the power plug

The power adapter can be used for connection to US, EU and UK power plugs. Slide the regional adapter into the base part.

Connecting



- Connect LAN port to internet for connection to the cloud.
- Connect the power supply.

- B) LAN1, for connection to cloud
- C) LAN2, for future features, not connected
- D) Reset button
- E) USB-C power input
- F) Ethernet (RJ45) port
- G) Ethernet cable

Commissioning

- Download the MasterConnect app from Google Play store or Apple App store and install it.
- Set up your MasterConnect system with lights. See the Philips MasterConnect app installer manual at https://www.lighting.philips.com/prof/led-electronics/masterconnect-system/masterconnect-sensors/LP_CF_9218075_EU/family
- Add the gateway to your MasterConnect project.

Reset

- The user can trigger a reset by using a paperclip and pressing the pinhole button on the powered device.
- Soft-Reset: Reset **some** parameters to factory default and reboot. Press button between 2 and 5 seconds.
- Hard-Reset: Reset **all** parameters to factory default and reboot. Press button between 10 and 20 seconds.
