

AGM 2021 VOTING RESULTS

Summary of resolutions taken at the Annual General Meeting of Shareholders of Signify N.V. held on Tuesday May 18, 2021 (the "**AGM 2021**").

On April 20, 2021, after processing of all settlements of that date (the Record Date), the total number of issued shares in Signify N.V. was 128,344,238 ordinary shares. Considering the number of shares held in treasury, which amounted to 4,031,961 on that same date, the number of voting rights amounted to 124,312,277.

The total votes represented at the AGM 2021 was 96,166,648, representing 77.36% of Signify's issued and outstanding share capital on the Record Date. Percentages in this summary have been rounded.
